Alaska	Senators receive up to \$20,000/year and Representatives receive up to \$12,000/year for postage, stationary, stenographic services, and other business expenses.
America Samoa	No data available.
Arizona	No funding.
Arkansas	No information reported on Senate. House committee chairs and vice chairs can qualify for certian office reimbursement.
California	No funding avaliable for Senate. House assembly office expenses are paid directly and maintained by the Assembly Rules committee, no limits. House staffing expenses are paid and maintained by the Assembly Rules Committee, no funding limits.
Colorado	No funding avaliable for office supplies for legislators. Regarding staffing, members may hire up to two aids at \$20/hour, but only up to 1,800 hours per year per member.
Connecticut	Senate members recieve \$5,500/year, and House members recieve \$4,500/year.
Delaware	Senator members may recieve up to \$7,481 at the decretion of the legislator for office supplies. House members do not recieve funding.
District of Columbia	Legislators may use \$19,083/year for office supplies, equipment, furniture, websites, cell phones etc. \$631,607 may be used for staff salaries.
Florida	No information reported.
Georgia	Legislators may recieve \$7,000/year. Funds may cover meals, lodging, printing of non campaign newsletters, supplies, mileage, nonpartisan dues and conference registration fees, taxis/lyft/uber, office equipment, postage, personal aide, telecom, office district rent.
Guam	No data available.
Hawaii	Legislators are allotted \$15,952/year for expenses for items and services not provided by the Senate/House, but related to official legislative business. Staff funding varies according to positions for permanent and session-only staff.
Idaho	Legislators recieve \$2,500/year for unvouchered constituent expenses, and additional amounts are paid incrementally to those serving from larger geographic areas
Illinois	Representatives recieve \$179,000/ year to operate their districts. Expenses paid from the district office allotment must pertain to the operation of the district office and benefit the constituents of the district or aid the Representative in fulfilling his or her duties. Staffing expenses come out of the \$179,000/year allotment.
Indiana	Senate members receive \$78.40 per day, House members do not have funds avalaible.
Iowa	Legislators recieve \$300 per month for constituent costs
Kansas	No funding is provided.
Kentucky	Legislators recieve \$1931.59/month during interim for members sworn in after 1/1/23; \$1,788.51 for members sworn in before 2023.

Louisiana	Senate members revieve \$1,000/month for office expense covers the following expenses for the district office: utilities, electricity, gas, water, sewer fees, cable, telephone expenses, janitorial services, office supplies, and postage & shipping charges. Rent for the district office comes from this amount first; any amounts remaining are used for vouchered expenses. House
	members receive \$1000/month for rent and office expenses and \$1500/month to extra expenses including office, travel, and printing expenses. House staffing pay starts at \$2000/month and increases with assistant's experience and legislator's time in office.
Maine	No data available.
Maryland	Senators receive \$68,685/year and delegates receive \$78,571/year for expenses and staffing. Senators also receive one institutionally compensated legislative aide.
Massachusetts	\$20,468/year office stipend for legislators who live 50 miles or fewer from the state house; \$27,290/year for members who live more than 50 miles from the state house. This funding can be used for travel.
Michigan	No information reported on Senate. House office allotments are \$135,000/year for majority office and \$132,000 minority office. The House does not support district offices, these figures include staff salaries.
Minnesota	No funding is provided.
Mississippi	No funding is provided.
Missouri	Senators receive \$114,718 per year for staff salaries and \$24,100 per year for mailings, travel, supplies and other office expenses. Senators also have a \$114,718 for staffing avalaible. House members receive \$700 monthly allotment but must in turn expense report with proof of purchase prior to reimbursement, and recive no staffing funds.
Montana	No funding is provided.

New Hamphire	Ther are no stipend regarding offices for legislators. Regarding staffing, each senator is assigned an Aide or Administrative Assistant, with some Admin Assistants being assigned to more than one senator. Assignment is determined by Senate President and cost varies.
New Jersey	The Legislature provides Senators stationery for each legislator and 10,000 postage stamps/year. District office expenses are handled by the Office of Legislative Services. House members are granted district offices rent which is handleed by the Office of Legislative Services. Both Senate and House members are grated \$135,000/year for district office personnel.
New Mexico	No funding is provided.

North Carolina	All legislators are granted \$2,275/biennium for office expenses. No staffing allowance is provided.
North Dakota	All legislators are granted \$90/month phone and data stipend, and \$200/month phone and data stipend starting July 1, 2023. No other office or staffing allowances are granted.

Oklahoma	Senators are provided \$1,500/year for office supplies. The Oklahoma legislature does not provide a district office, only an office at the state capitol. No staff funding is provided. 	salaries and \$6243 for services and supplies

Texas	Senator receive \$63,000 per month for staff salaries and staff travel. All other office expenses are not budgeted, but provided as
	needed. Representatives recive \$19,250 per month to cover office expenses for any month that falls wholly or partly during a
	regular session or special session.; \$17,500 for any month that does not fall wholly or partly during a regular or special session.

Virginia	Senate Leadership recieves \$21,000 annually (\$1,750 monthly) Legislators \$15,000 annually (\$1,250 monthly) for office
	expenses. Senate Leadership recieved staffing funds of \$144,704 annually for 1 fulltime staffer, and Senate Legislators recieve
	\$66,891 annually fr staffing. All members receive additional funding of \$57,783 for non-benefited employee(s). House members
	are allowed \$15,000 per year for office expense (paid as taxable income) and \$66,890 for legislative staffing.
Washington	Senate members recieve \$15,600 each biennium for office expenses. House members recive a \$9,000 per calendar year in the
	form of a Buisness Expense Account.

Wisconsin	Senate members recieve \$55,955/biennium for office expenses. Majority party Senators generally have 4 staff members, and
	minority part have 3 staff members. House members recieve \$22,500 for office expenses for the two year session. It does not
	cover a district office. The money is largely used for mail, office supplies, letterhead, envelopes, flags, citations, in-state travel,
	and out-of-state travel.
