






FMAG Declaration Frequency

Current Challenges

- Increasing Frequency, Severity, and Complexity of Disasters:
 Overlapping events, cascading effects, dis/mis/mal-information, social
 justice and equity, sea level rise, distrust of government, limited English
 proficiency, nontraditional roles of EM, changing expectations,
 geopolitics
- Rising Costs: Inflation and increased expenses for disaster mitigation, prevention, response, and recovery.
- Economic Volatility: Unpredictable economic and legislative conditions impacting funding and resources.



Importance of Federal Funds

- Role in Crisis Management: Essential for immediate response and recovery.
- Support for Local Government: Helps lighten the financial burden on local and state governments.
- Sustainable Recovery: Contributes to long-term rebuilding and resilience.



Key Non-FEMA Federal Funding Sources

- HUD: Community Development Block Grant for Disaster Recovery (CDBG-DR)
- USDA: Livestock forage assistance, indemnity, emergency assistance for livestock, honeybees, and farm-raised fish, livestock relief, crop losses, farm loans
- SBA: Economic injury disaster loans, physical damage loans, mitigation assistance





FEMA Disaster Assistance Funds

Public Assistance

 Grants to state, tribal, territorial, and local governments, and certain types of private non-profits so communities can quickly respond to and recover from major disasters or emergencies.

Individual Assistance

 Financial assistance and direct services to eligible individuals and households affected by a disaster, who have uninsured or underinsured necessary expenses and serious needs.

Strategies for Incorporating Federal Funds

- Early Planning and Preparedness: Local jurisdictions should build potential federal funding into planning.
- Collaboration and Partnerships: Don't exchange business cards during a disaster. Build relationships now.
- Grant Writing and Management: Train staff in grant writing and grant management.
- Leverage Data and Technology: Use data to support funding requests. Pay attention to the 5th industrial revolution.

Strategies for Maximizing Federal Funds

- Prioritize Projects: Focus on high-impact projects that meet funding criteria.
 Don't skim the NOFO.
- Efficiently Allocate: Ensure funds are allocated efficiently and effectively.
 Embrace audits.
- Ensure Strong Compliance and Reporting: Maintain strict adherence to federal guidelines and reporting requirements.
- Focus on Building Resilience: Invest in projects that enhance long-term disaster resilience.





Challenges in Fund Management

- Bureaucratic Hurdles: Navigating complex federal requirements. Ask questions of your SMEs.
- Resource Limitations/Changes: Human resources and funding. Changing federal priorities and budgets. Limited staff and expertise in grant management.
- Timely Distribution: Ensuring funds are received, distributed, and used promptly. Have a reallocation contingency plan.





EMD 2025 Legislative Agenda

- Fund a study to identify best practices for a state individual assistance program.
- Fully fund the state public assistance program.
- Create a state incident management assistance team.
- Create a local emergency management capacity building grant.
