

### President's Message

Greetings ASLCS friends!



As I write this in the midst of the annual holiday season, I hope you are all finding the time, the time for EVERYTHING. The time to celebrate the multiple occasions that mark this festive period on the calendar from Halloween through New Year's Eve. The time to relax and recharge with social occasions and familiar traditions, finding togetherness and community, and last but not least, the time necessary to gear up and organize your office and your chamber for the upcoming legislative cycle.

It's a well-worn phrase that change is a constant in legislative life, but even as universally accepted as that phrase is, it seems like an understatement this year. This year, of the 7,383 legislative seats in the United States,

6,278 seats were up for election across 46 states. And we know what that can mean. From 2010 to 2021, 42 chambers switched control: 24 switched control once, 12 switched control twice, two switched control three times, two switched control four times, and one—the New Hampshire House of Representatives—switched control five times. As of this writing there will be over 1,600 new state legislators for 2023, and four of the 88 chambers involved in the election will switch partisan control.

And we get to tackle all of this regenerative transition, during the happiest time of the year!!! There's a phrase I've heard associated with the military that the Army feels they have been expected do so much with so little, they are eventually going to be able to do everything with nothing. After nearly 30 years in legislative service, I can relate. The legislative branch is usually a very small branch of government compared with the executive branch and the resources allocated to it are limited by unique factors. Firstly, most legislators, even the ones who set budgets, have no real idea what we do or what it takes to do it. Instead of providing adequate resources, limiting expenditures is seen as political expediency. And at the bottom of it, we work in a world where decisions are often just opinions rendered in anecdotes. Instead of objective performance measures, we are led by our own individual interpretations of the results that matter, and we end up pulling in different directions.

To counteract all this potential for chaos there's three things I have found useful in my legislative career:

- Set manageable goals. The latest research shows that the more control we have over our work, the less stressed we get. Meeting your priorities helps you feel a sense of accomplishment and control. So be realistic with yourself and others about workloads and deadlines.
- Communicate effectively. Be honest with colleagues or your boss about what you're going through. But don't just complain—suggest practical alternatives. Looking at a situation from someone else's viewpoint can also reduce your stress. Make allowances for other opinions, and search for little things you can agree on. Retreat before you lose control and allow time for all involved to cool off. You'll be better equipped to handle the problem constructively later.
- Ask for what you need. Ask leaders and supervisors to consider flexibility a new job criteria.
  Research shows that employees who work flexible schedules are more productive and loyal to
  their employers. Flex time and telecommuting are quickly becoming established as necessities in
  today's post covid world, and many employers are implementing work/life balance policies. Every
  reasonable person knows we all must step back from work responsibilities so that our personal life
  does not deteriorate.



### Q & A With Mr. President

Q: Tell us a little about yourself, your family and where you are from.

A: I'm an only child of two parents who both came from very small families themselves. Most of my grandparents were gone before I was born, because my parents were older when they had me. Consequently, I didn't grow up with cousins or extended family, but had close friends from school and the activities I took part in growing up. I liked school fine, but I never found it very difficult or interesting. I grew up in rural south Texas, so I was always outside. Two blocks from my house in one direction the scrub brush and cactus started and went pretty much forever. A few blocks in the other direction was a Dairy Queen where dilly bars were a quarter. It was a very small town where nobody locked their doors and everyone knew everyone else. I loved it, but looking back I sort of took it all for granted.

Q: How long have you worked for Oregon Legislature? Tell us about your years there.

A: I've held the Chief Clerk position since 2014, but my time in the Oregon legislature started in 1987. I was a college intern in the Oregon Senate as an undergraduate and completely enjoyed my time in a couple of different offices. That being said, I went to law school and moved to Seattle where I took a position on a Washington senator's staff while waiting for the state bar. I passed the bar but never left the legislature. Although I've not always worked for the legislative branch I've had staff positions on member's staff, caucus offices, and administrative position in the House and Senate in Oregon and Washington. I took a four-year deviation into the executive branch as a legislative coordinator for an executive branch agency, but I've always worked in and around the legislative branch of state government.

Q: What hobbies do you have?

A: I like to be outside, even if it's a little colder and rainier here in the Pacific Northwest than south Texas. Something most people probably don't think about for Oregon is that it's mostly open country. Hiking up to a waterfall and driving wilderness trails is the easiest way to brighten my mood. And the variation in landscape from high desert to mountains to coastline provides so many opportunities to get out and have those experiences in wide open nature.

**Q**: What are some of your favorite things about the society?

A: Of course, it's the people. We are such creatures of our chamber in ways that make us all a little different even though we have similar unique jobs. But, deep down, I see a lot of investment in an intangible concept of lawmaking. It would be a very different country without the integrity and honesty of the people of the Society. Sometime our jobs can be grindingly difficult, mentally and physically. But we find ways to rise above challenges, we devise systems to function in times of conflict, we know we are inheriting a heirloom and need to leave a legacy.

Q: What direction would you like to see the society go in?

A: I think we need to look at how most people are raised in social media and cable news, in narcissism and conflict, and try to instill in them a respect for the democratic process. Conflict and confidence aren't something we need to engineer out of the process, but we will get a much different government with those aspects taking center stage. Training in civics and pluralism can be something we do without changing all that much of how we do our jobs. Programs in our chambers can be called civics education because they expose people to the actual, unfiltered truth of the process, before the narrative is commandeered by political ideologues. That's why I'm so committed to our youth programs in the Oregon House. It's harder for people to hate something after they've worked to contribute to it and become a valuable part of it.

#### **Meeting Minutes**

#### **Call to Order**

The meeting of the Bylaws and Standing Orders Committee was called to order by the Chair, Obie Rutledge (Ore.), at 1:33 p.m.

#### **New Business**

ASLCS President-Elect Tim Sekerak briefly addressed the committee outlining initiatives he hoped the committee would look into including two items of business coming from the executive committee.

Brad Young (Ohio) discussed the Associate Exchange Program and the amount of reimbursement provided and indicated that the Standing Orders may need adjusted to provide more opportunity for participation in the program. The Committee discussed two proposed revisions to the Bylaws and Standing Orders:

- A request by NCSL that ASLCS provide two
  parliamentarians for the annual summit and the
  process whereby the Society would choose two
  principal members to serve as parliamentarians.
  NCSL had indicated that the registration fees
  would be waived for the chosen parliamentarians.
  It was suggested that this Committee develop
  and recommend language for the Executive
  Committee to consider.
- Update the Standing Orders to add an additional associate member to the Executive Committee to serve as an "Associate Vice President Elect." It was noted that the new position would be available to assist the Secretary-Treasurer in their duties; it would also add one year to the associate leadership track.

Before the committee begins work on any revision, the Secretary-Treasurer must first forward the request on behalf of the Executive Committee.

#### Call to Order

#### **Approval of Minutes**

Upon motion by Joy Engelby (Mo.), seconded by Rebecca Silbernagel (Vt.), the minutes from the NCSL Legislative Summit in Denver, Colorado were approved.

#### **Old Business**

Lacy Ramirez (Ore.) started discussion about the Technology concurrent session. Rebecca Silbernagel (Vt.) talked about the challenges of having someone on the panel attend remotely. There were some technical difficulties. They were resolved, but something to keep in mind going forward. There was a lot of time for questions. The session seemed to be a little lengthy and there were no set guidelines on how long someone on the panel could speak. Lacy Ramirez (Ore.) said that she would look into navigating time parameters going forward.

Discussion turned to the ASLCS website, as this committee is tasked with updating ASLCS site.

Lacy Ramirez (Ore.) said that Holly South (NCSL) mentioned that the NCSL site as a whole is getting updated. There was a discussion about putting the roster on-line with a privacy component. Meggan Foesch (Wis.) said that if the roster were on-line, she could easily go in and modify titles and other things. Once the roster is printed and the title or something is wrong, you cannot easily correct it.

#### **New Business**

David A. Ward Scholarship – Lacy Ramirez (Ore.) explained what this is and that this committee is who selects the recipient. Nate Sanko (Pa.) was this year's recipient. This committee can award up to two of these scholarships.

Lacy Ramirez (Ore.) and Becky King (Ky.) will be added as Facebook admins. How can we move beyond just a Facebook page? The ListServ emails are often overwhelming while a website could be visited at members' convenience. Answers to questions would reside in one spot. Other ideas include a suggestion box for survey ideas and housing future surveys in a section that could be filled out rather than the email blast. Future survey topics were discussed, and it is our goal to send out 3 short surveys a year. Some topics suggested included committee structures, compensation or retention of staff and different state legislature rules.

#### **Obituaries**

Steven Arias, former chief clerk of the New Mexico House of Representatives, passed away on Aug. 28, 2022. First been elected to the role in 1983, Arias served as chief clerk for 32 years and retired in 2014.

During his time as chief clerk, Arias was an active member of the American Society of Legislative Clerks and Secretaries (ASLCS) and served on the ASLCS Executive Committee, the group's governing board, three times. He was also a member of the 2000 Mason's Manual Revision Commission, which is responsible for updating the Mason's Manual of Legislative Procedure. In 2012, ASLCS honored his service to the New Mexico House of Representatives and ASLCS with the Legislative Staff Achievement Award. Susan Schaar, clerk of the Senate of Virginia, recalled Arias' love and enthusiasm of ASLCS.

Patrick O'Donnell, clerk of the Nebraska legislature, remembered Arias as someone "who exemplified a love for his state and a passion for his work as

Chief Clerk of the New Mexico House of Representatives, and a mentor who taught many of us a respect for the legislative institution and a commitment to public service."

In fact, Arias' passion for the legislative institution and mentoring clerks, secretaries and their staff was put into action when he sought to establish parliamentary relationships with clerks in Mexico and Central America. Arias served as the founding member of ANOMAC (La Asociación Nacional de Oficiales Mayores de los Congresos de los Estados y Distrito Federal or the National Association of Chief Clerks of Mexico's State Legislatures and the Federal District of Mexico). Arias' participation and leadership laid the groundwork for a mutually beneficial relationship between ASLCS and ANOMAC that continues today. Liz Clark, secretary of the Alaska Senate, reflected that "though his loss will be felt deeply by ASLCS and ANOMAC members, his contribution to both societies will be a long-lasting reminder that we all do better when we collaborate. Joining people together in both work and play and making them feel at home, como familia, was Steve's superpower."

In 2018, the New Mexico House of Representatives passed House Memorial 105, which honored Arias' more than 40 years of dedicated and loyal service to the chamber and the New Mexico Legislature. Arias is remembered by House members, including Speaker Brian Egolf (D), for his deep commitment to the legislative institution, his knowledge and enforcement of legislative procedures, practices and traditions and his willingness to mentor new members as they started their legislative services.
