Overview

- Founded in 1961, the Office of Local Defense Community Cooperation continues to assist communities across all 50 states and the U.S. territories and was designated a Field Activity within the Department of Defense.
- Provides technical and financial assistance to states, territories and communities that are invested in the defense mission.
- Assistance supports the readiness and resiliency of both defense installations and defense communities, a priority for the country's National Defense Strategy.

Authorities

- The Office of Local Defense Community Cooperation executes assistance on behalf of the Department of Defense under statutory authority [Title 10, Section 2391] to make grants, conclude cooperative agreements, and supplement other Federal programs to work with states and communities.
- Executive Order 12788, as amended, establishes the Defense Economic Adjustment Program and Economic Adjustment Committee: “The head of the Department of Defense's Office of Local Defense Community Cooperation shall provide all necessary policy and administrative support for the Committee and shall be responsible for coordinating the application of the Defense Economic Adjustment Program to Department of Defense activities.”

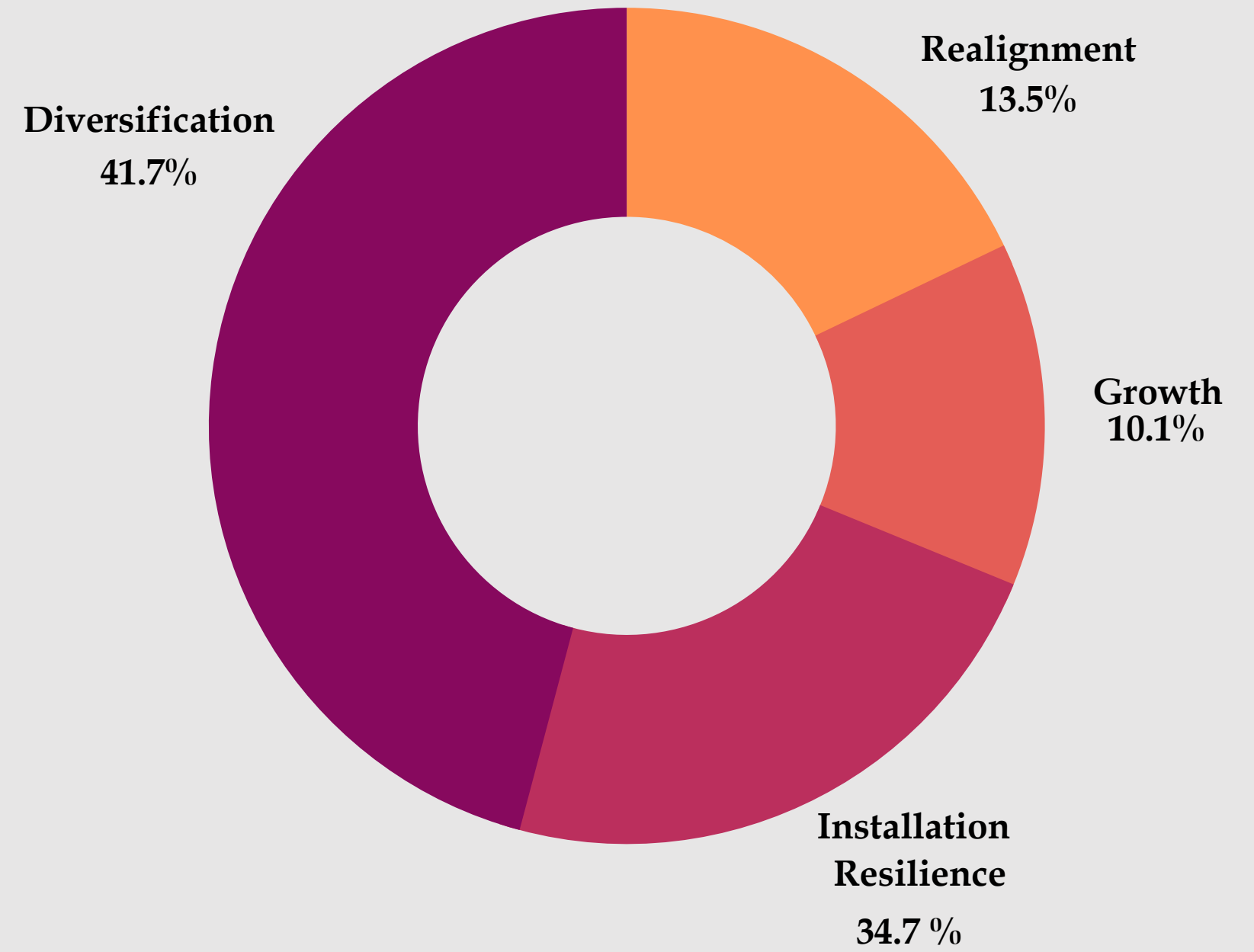
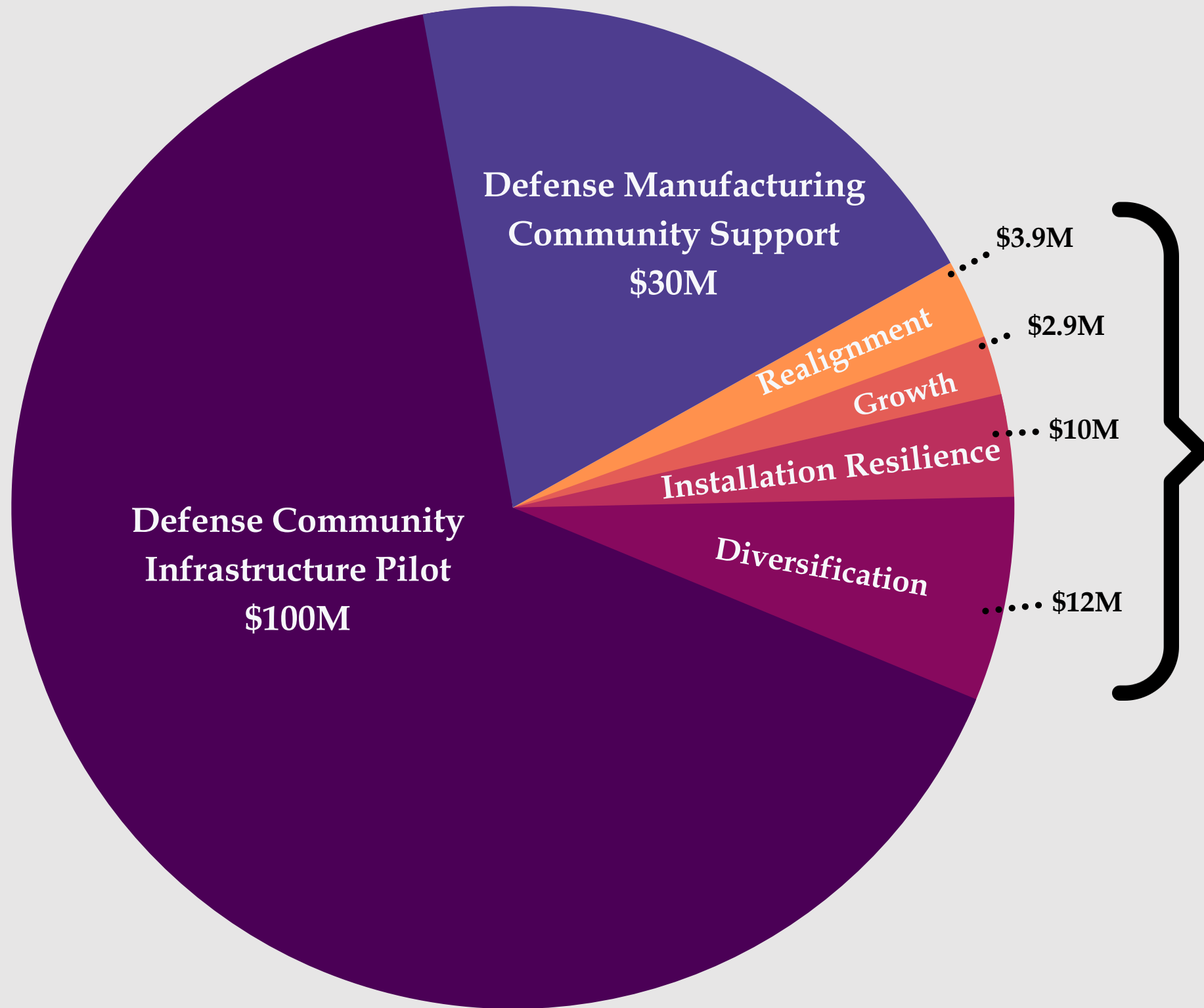

Diversification & Modernization

- Understand defense dependencies, plan, and carry out what can be done to lessen their future vulnerabilities and help to modernize.
- Non-competitive program; 10% non-federal match.
- The program provides states, territories, and communities the ability to:
 - review local industrial base and installation defense dependencies;
 - assess community, workforce, and business capabilities; and,
 - support efforts to deliver workforce development/training, transportation, and other infrastructure investments to address future needs of installations and the industrial base, education system improvements, and housing availability in tandem with emerging defense priorities.

Diversification & Modernization

- Understand installation and/or industrial base dependencies = plan and carry out what can be done to lessen future vulnerabilities – modernize
 - ✓ Not just to diversify non-Defense opportunities
 - ✓ Public infrastructure to support local defense industry and installations
 - ✓ Defense Spending by State Report for Fiscal Year 2021
- What happens if the Department pursues divestment of facilities, supplier expansions?
- What happens if your local industry has to modernize to deliver the technology and innovation needed in the future?

Defense Manufacturing Community Support Program

- Supports long-term community investments to strengthen national security innovation and expand the capabilities of the local defense industrial ecosystem.
- Priority sectors include: critical minerals, space, biotechnology, hypersonics, kinetic capabilities, energy storage and batteries, castings and forgings, microelectronics, and the submarine and shipbuilding workforce.
- Competitive program; 20% non-federal match; eligibility is through consortia.

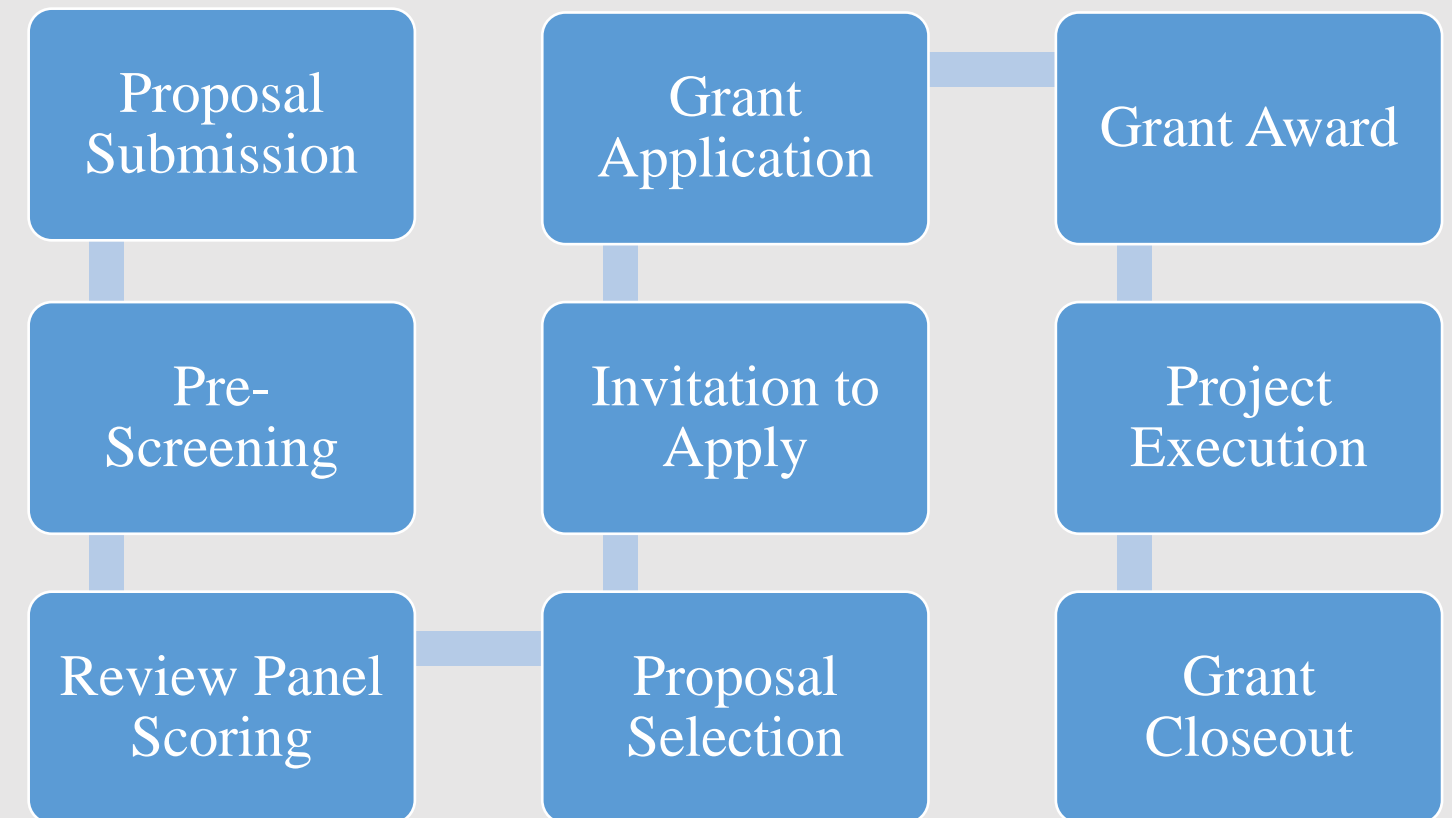

Defense Manufacturing Community Support Program

- Subject to annual appropriation and authority changes, publish a Notice of Funding Opportunity (NOFO).
- All proposals received by the Proposal Deadline are first pre-screened for eligibility, then competitively evaluated by a DMCSPP Review Panel comprised of representatives from: Materiel Readiness; Industrial Base Policy; Research & Engineering; OLDCC; National Institute for Standards and Technology – Manufacturing Extension Partnership Program; and Department of Labor – Employment and Training Administration.
- The highest ranked proposers receive Defense Manufacturing Community designation and are invited to submit a grant application.

- Submit proposals now – due June 26, 2023
 - ✓ Notice of Funding Opportunity posted April 24, 2023 (Grants.gov OLDCC-23-F-0002)
 - ✓ Expand the manufacturing ecosystem, including workforce development (there are not enough trained workers)
 - ✓ Focus on delivering technology and innovation at speed of relevancy
 - ✓ Remedies for the “Valley of Death” for start-ups
 - ✓ Leverage state and local economic development capabilities

- Assistance to state and communities to improve military installation resilience to mitigate impacts from climate, vulnerabilities and other threats.
- Assist in alleviating and preventing incompatible development that is likely to impair the continued operations of a Department of Defense installation, range, special use air space, military operations area, or military training route.
- Non-competitive program; 10% non-federal match.

Installation Resilience

- Leverage installation energy resiliency and master plans – partner with local installation
- Opportunity to look beyond the obvious - You truly don't know what you don't know
- Metrics – think about who is being affected (entire community population)
 - ✓ Think number of people affected and dependences
 - ✓ Diversity, equity and inclusion
- Table top exercise – gauge hard + soft infrastructure needs with stakeholders
 - ✓ Understand public infrastructure and services (transportation, income-based housing)

Community Noise Mitigation

- Program in development for noise from fixed wing aircraft on active, guard, reserve, and installations with new platforms.
- An eligible grantee could consider impacts to covered facilities including hospitals, daycare facilities, schools, facilities serving senior citizens, and private residences.
- FY22 appropriation \$75M to be obligated by September 30, 2025.
- 10% non-federal match.
- Draft Notice of Funding Opportunity will be published July 1, 2023, with 120-day comment period.

Defense Community Infrastructure Pilot Program

- DCIP is designed to address deficiencies in community infrastructure, supportive of a military installation, in order to enhance military value, installation resilience, and military family quality of life.
- Competitive program; 30% local cost share required for non-rural areas (rural is population less than 100,000 at the project location).
- “Construction ready” - consider timelines to meet National Environmental Policy Act actions, permitting requirements, availability of other Federal and non-Federal contributions (not for shopping).

Defense Community Infrastructure Pilot Program

- State or local governments or partnerships between ineligible/eligible entities.
- FY23 included program changes, review the Notice of Funding Opportunity carefully for changes if reapplying.
- Expanded project eligibility for:
 - Property either located off of a military installation or on property under the jurisdiction of a Military Department that is subject to a real estate agreement (including a lease or easement)
 - Supporting strategic seaports
 - Historically Black Colleges and Universities ROTC facilities



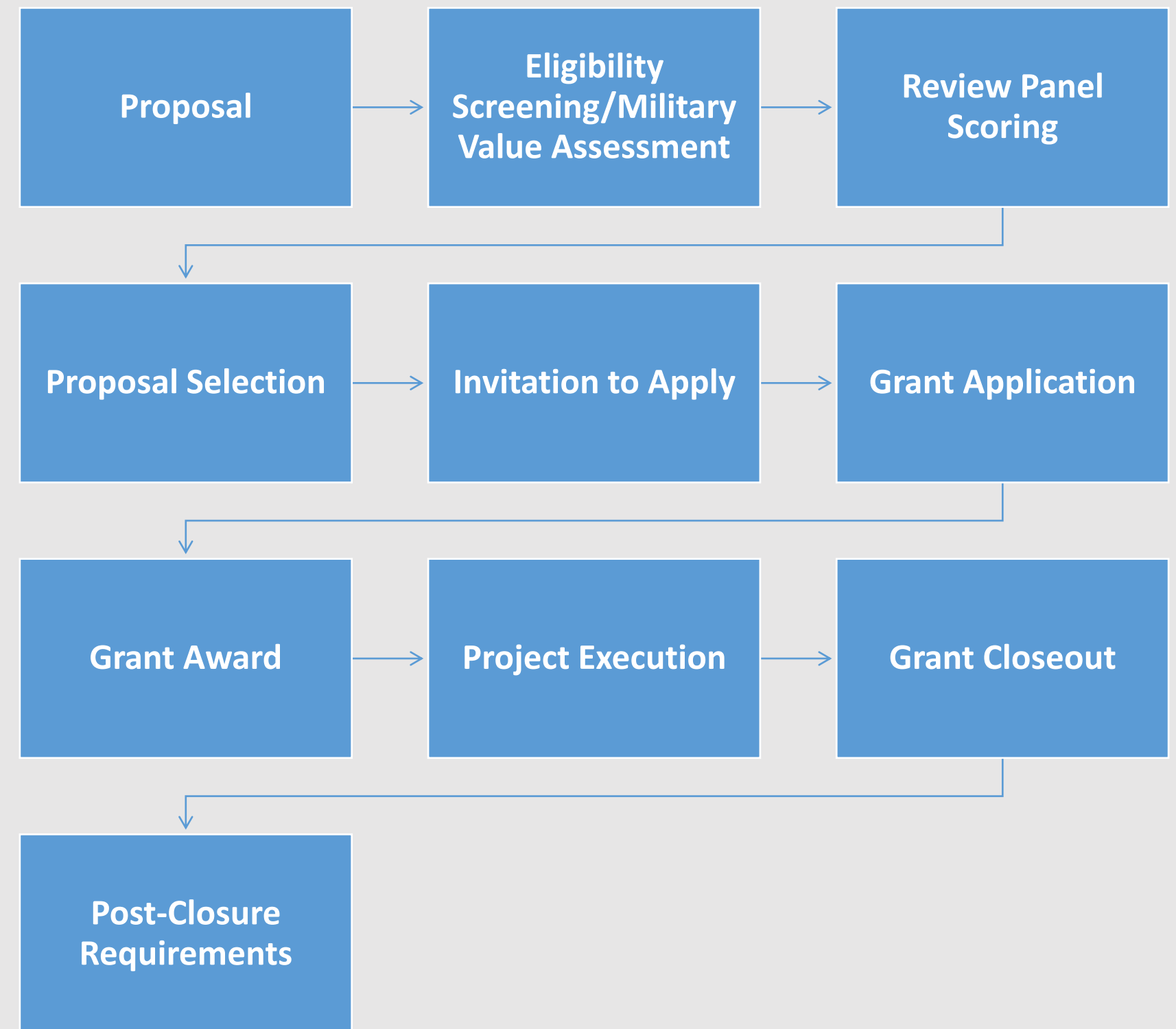

Defense Community Infrastructure Pilot Program

Additional Eligibility Items:

- Endorsed by the local installation commander representing the installation benefiting from the proposed project (prioritized if multiple)
- Project must be complete and usable
- Transportation, school, hospital, police, fire, emergency response, or other community support facility; or
- Water, wastewater, telecommunications, electric, gas, or other utility project

Defense Community Infrastructure Pilot Program

Military Value

1. The current and future mission capabilities and the impact on operational readiness of the Department of Defense's total force, including the impact on joint warfighting, training, and readiness.
2. The availability and condition of land, facilities and associated airspace (including training areas suitable for maneuver by ground, naval, or air forces throughout a diversity of climate and terrain areas and staging areas for the use of the Armed Forces in homeland defense missions) at both existing and potential receiving locations.
3. The ability to accommodate contingency, mobilization, and future total force requirements at both existing and potential receiving locations to support operations and training.
4. The cost of operations and the manpower implications.

**69 FR 6948, February 12, 2004
Final Selection Criteria**

The final criteria to be used by the Department of Defense to make recommendations for the closure or realignment of military installations inside the United States under the Defense Base Closure and Realignment Act of 1990, Public Law 101-510, as amended, 10 U.S.C. 2687 note, are as follows: In selecting military installations for closure or realignment, the Department of Defense, giving priority consideration to military value.

- Submit proposals now – due June 23, 2023
 - ✓ Notice of Funding Opportunity posted March 24, 2023 (Grants.gov OLDCC-23-F-0001)
 - ✓ Strategic seaports, leased land, and Historically Black Colleges and Universities ROTC facilities - expanded eligibility
 - ✓ Webinar recording and slides available on the program page at OLDCC.gov
- Ensure non-OLDCC funding is obligated - other Federal funds awarded
- Understand NEPA and what to do - no assistance from OLDCC
- Be exact and concise
