Dear Chairman Moran and Ranking Member Shaheen, Chairman Serrano and Ranking Member Aderholt:

We, the undersigned national organizations representing a broad cross-section of the criminal and juvenile justice systems, thank you for your strong, consistent and thoughtful leadership on federal assistance for state, tribal and local evidence-based criminal justice programming. In particular, we applaud your steadfast support for the Byrne Justice Assistance Grant (Byrne JAG) program and respectfully request that the Fiscal Year 2020 Commerce, Justice, Science and Related Agencies (CJS) appropriations bill begin to return funding to the program that has been lost in recent years.

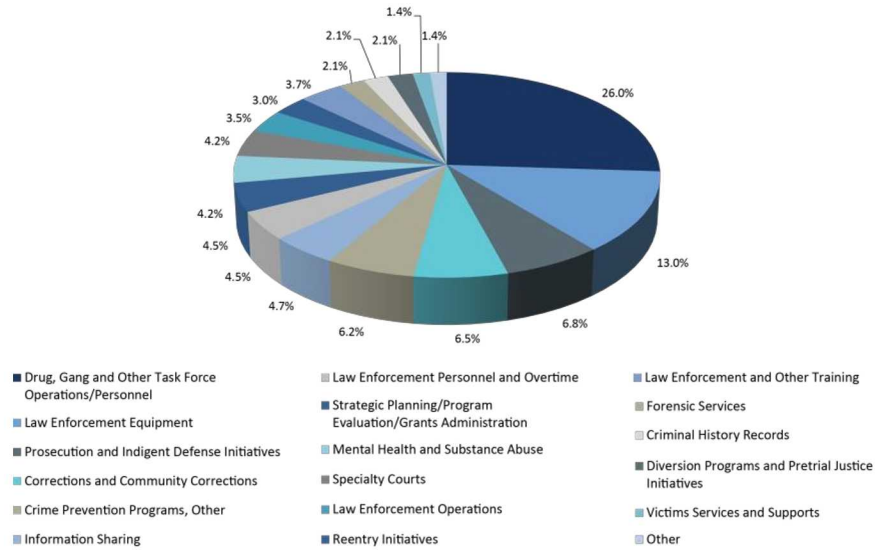
Byrne JAG is the cornerstone federal crime-fighting program, supporting the federal government's crucial role in spurring innovation, as well as testing and replicating evidence-based practices nationwide. Because Byrne JAG is flexible, states and local communities are able to use funding to address needs and fill gaps across the entire criminal and juvenile justice systems – in juvenile delinquency prevention, law enforcement, courts and specialty courts, prosecution and indigent defense, corrections, victim assistance, mental health services, reentry programs, and other practices to improve transparency and fairness in the justice system.

This flexibility is the hallmark of the Byrne JAG program. This flexibility also means that states can respond quickly to emerging needs and crises. For example, many states were able to pivot swiftly to the prevention, treatment and recovery from opioid addiction. This flexibility also gives states and local governments a mechanism for working across systems to fill gaps. Byrne JAG is able to leverage other justice and public health funding to create programs that otherwise may be impossible within the constraints of other grant programs. This is helpful, even vital, when considering programs to divert the mentally ill from jail and to address the needs of the justice-involved with substance use disorders.

Byrne JAG grants also serve as a catalyst for collaboration within communities and across states, including the critical role multijurisdictional drug task forces play in targeting regional drug trafficking organizations. This cross-jurisdictional model is being replicated in states to tackle other cross-boundary crimes, such as human trafficking and cybercrime, while saving money and increasing efficiency in the process.

The National Criminal Justice Association (NCJA) gathers a wealth of information about how states and local governments allocate Byrne JAG funding to meet system needs through periodic surveys of the State Administering Agencies (SAAs). From the most recent survey, we know that Byrne JAG dollars were invested broadly across all segments of the criminal justice system in FY16, as illustrated in the chart below.

As illustrated by the wide-range of signatures below, Byrne JAG is supported by a broad and dedicated coalition of national organizations from across the criminal and juvenile justice systems. We recognize the central role Byrne JAG plays in preventing victimization; supporting innovative law enforcement practices; supporting the fair administration of and access to justice; serving and protecting crime victims; and leveraging other federal, state, local and private dollars in the balanced functioning of the criminal justice system.

We recognize the competing pressures you face as you seek to prioritize funding for the many important programs in the CJS bill. Yet funding for Byrne JAG has been reduced by 35 percent since FY10, causing a serious contraction in the reach of Byrne JAG-funded programs across the states and territories and hindering our ability to prevent and deter a rise in violent crime, to confront the opioid epidemic, to reduce recidivism, and to improve outcomes for individuals with addiction and mental illness who come into contact with the justice system. For these reasons we respectfully request a return to the FY10 funding of \$520 million for Byrne JAG in the FY20 CJS appropriations bill.

Thank you for your leadership and your steadfast commitment to the Byrne JAG program.


