Census 2020

The decennial census is the single largest civilian undertaking in the U.S. The results of this federal data-gathering effort are used for congressional apportionment, redistricting, the allocation of over \$1 trillion in federal dollars each year, and decision making by businesses and policymakers. Our team tracks census processes, legal standing and data delivery schedules—and can provide general information, as well as examples of how states have maximized their “count” and thus their political clout.
